NOTICE OF SPECIAL CONGREGATIONAL MEETING Sunday, February 10, 2019 12:30 PM — Social Hall

The Board of Trustees of First Unitarian-Universalist Church of Detroit has called a special meeting of the Congregation for Sunday, **February 10**, **2019, at 12:30 PM** in the Social Hall, for the purpose of electing church members to serve on a Nominating Committee.

Article VIII(2)(B) of our Bylaws requires the annual election of five church members to serve on a Nominating Committee. A function of this Committee is to identify candidates to serve as Board officers and trustees and as delegates to our regional and national assemblies. The Nominating Committee must convene soon in order to begin the work to identify candidates to present for vote of the membership at our annual congregational meeting in May.

A majority of the Nominating Committee Members who were elected at the May 2018 annual meeting are unable to serve. A special congregational meeting must be held to elect replacements.

Article IV(2)(C) allows special meetings of the Congregation to be called by the Board of Trustees. Subsection (D) requires notice of the time and place of all congregational meetings to be published in the Church Newsletter mailed and/or e-mailed to the last known address of each member thirty (30) days prior to the meeting. The Board is publishing this special edition newsletter in order to meet the notice requirements of the bylaws.
